READ THE TERMS OF THIS AGREEMENT AND ANY PROVIDED SUPPLEMENTAL LICENSE TERMS (COLLECTIVELY "AGREEMENT") CAREFULLY BEFORE USING THE SOFTWARE. BY USING THE SOFTWARE, YOU AGREE TO THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL THESE TERMS, PROMPTLY DELETE THE SOFTWARE.

1. LICENSE TO USE

WAGO Kontakttechnik GmbH & Co. KG, Hansastrasse 27, 32423 Minden, Germany (hereinafter "WAGO") grants you a non-exclusive and non-transferable license for the internal use only of the accompanying Software and documentation and any error corrections provided by WAGO (collectively "Software") to the extent of this AGREEMENT, the Application Note and the User Instruction

2. RESTRICTIONS

Software is confidential and copyrighted. Title to Software and all associated intellectual property rights is retained by WAGO and/or its licensors. You may not make copies of Software, other than a single copy of Software for archival purposes. You may not modify, decompile, reverse engineer Software. Software is not designed or licensed for use in health care, on-line control of aircraft, air traffic, aircraft navigation or aircraft communications; or in the design, construction, operation or maintenance of any nuclear facility. You warrant that you will not use Software for these purposes.

3. WARRANTY

Because of the various hardware and software environments into which the Software may be put, no warranty of fitness for a particular purpose is offered. Good data processing procedure dictates that any program be thoroughly tested with non-critical data before relying on it. Warranty of WAGO shall be in accordance with the donation law of the German Civil Code (BGB).

4. LIMITATION OF LIABILITY

Liability of WAGO shall be in accordance with the donation law of the German Civil Code (BGB).

5. TERMINATION

This AGREEMENT is effective until terminated. You may terminate this AGREEMENT at any time by destroying all copies of Software. This AGREEMENT will terminate immediately without notice from WAGO if you fail to comply with any provision of this AGREEMENT. Upon Termination, you must destroy all copies of Software.

6. DATA PROTECTION

You are at any time the sole owner of all data stored by the you in the Software. Accordingly, you are solely responsible for all content used and data processed by it. Accordingly, you shall observe all applicable data protection regulations. If you collect, process or use personal data, you guarantee that you are authorized to do so under applicable (particularly data protection) rules. For the avoidance of doubt, you shall be deemed the controller in terms of data protection law with regard to all personal data, and shall therefore continually review whether processing of such data through the use of the Software is permitted by applicable law. WAGO shall store and process your personal data only to the extent necessary to provide the rights to use the Software as contracted, and only to the extent permitted by law. WAGO takes no cognizance of the content of the stored or processed data and categorically does not inspect content used with the Software. 7. GOVERNING LAW AND JURISDICTION

8. OPEN SOURCE SOFTWARE

To the extent the Software contains open source software -which is mentioned in the readme_OSS file of the Software- Annex 1 applies.

Annex 1

OPEN SOURCE SOFTWARE

If the Software contains open source software (also referred to as “OSS” herein), this is mentioned in the readme_OSS file of the software (or in the file that corresponds to this). You are authorized to use OSS beyond the normal use in accordance with the OSS license terms that are applicable in each case. These OSS license terms are enclosed with the Software and, relative to the holders of rights, have priority over this AGREEMENT. The OSS license terms also have priority to the extent that, based on the combination of OSS components with proprietary components, they also grant the User certain rights of use in relation to the proprietary components or such rights of use are to be granted according to the OSS license terms of WAGO. If requested, WAGO will provide the OSS source code to you in exchange for corresponding reimbursement of expenses, provided that the license terms for OSS provide for such delivery of the source code.
